Stage 2: Self evaluation 14 Dec 2022 – 19 Feb 2023 [HCPs] / 26 Feb 2023 [ERNs]


Purpose

Assess to which extent ERNs / HCPs have achieved the objectives planned


Tasks

- Fill in and submit the **ERN/HCP self-evaluation form**
- Review **criteria** and measurable elements
- Provide evidences of fulfillment
- **Acknowledge** the self-evaluation of the ERN and its members

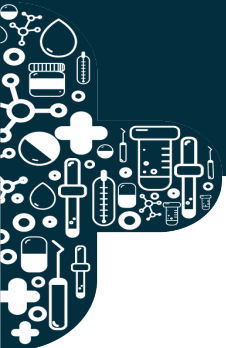
Stage 2: Self-evaluation

14 Dec 2022 – 19 Feb 2023 [HCPs] / 26 Feb 2023 [ERNs]



Key aspects

- **Log in** details to access the platform will be sent to the ERN and HCP representatives
- **Evidence** to support the ME need to be collected **in advance**
- **Comments and scoring** for all ME must be fulfilled
- **Evidence** documents required for different MEs can be **re-used**
- **Scoring** will be **adapted** to each ME (following the Technical Toolbox) in the platform
- ERN coordinator must do an **acknowledgement** check of its members' submission



Stage 3: Technical Evaluation

20 Feb 2023 – 18 May 2023 [HCPs] / 27 Feb 2023 – 27 Mar 2023 [ERNs]



Purpose

Check the fulfillment of the ERN/HCP operational criteria and the achievement of objectives



Tasks

- Provide **additional information** requested by the IEB

ERNs and HCPs to be visited:

- Set up time and date for **interviews (ERNs) and on-site audit (HCPs)**
- Facilitate communication with **patient representatives (ENRs) and patients (HCPs)**
- Coordinate the participation of work-package responsible **(ERNs)**
- Coordinate the interviews with professionals **(HCPs)**
- Facilitate the **medical records** review (HCPs)

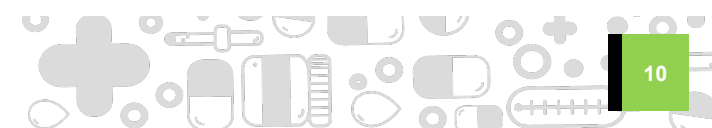


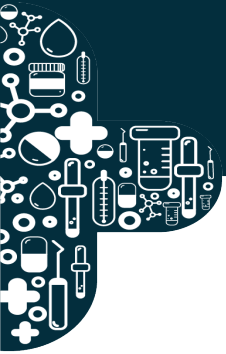

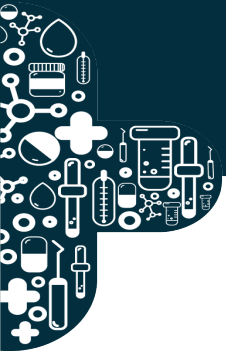
Stage 3: Technical Evaluation

20 Feb 2023 – 18 May 2023 [HCPs] / 27 Feb 2023 – 27 Mar 2023 [ERNs]



Key aspects

- Evaluators must sign a **confidentiality** agreement
- Evaluators will not have access to **patient information** unless shared by the HCPs
- IEB will select the **patient representatives** to be interviewed from the list provided by the ERN
- **Onsite audits** will:
 - be scheduled at least 2 months in advance
 - take place between 09 Mar 2023 and 18 May 2023
- **Interview with patients:**
 - Each participant must sign a writing consent
 - An independent interpreter will be needed
 - IEB will suggest the requirements to select the patients to be interviewed at least one month in advance
 - HCPs will contact with patients, not the IEB



Stage 4: Evaluation results

28 May 2023 – 04 Sep 2023



Issue a report with the results of evaluation as well as comments and recommendations



Tasks

- Send **comments** to the draft evaluation report
- Elaborate and implement **improvement plan** (“*not satisfactory*” only)

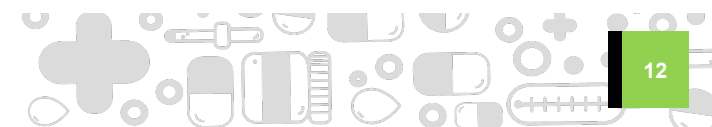

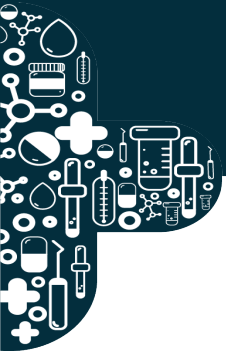
Stage 4: Evaluation results

28 May 2023 – 04 Sep 2023



Key aspects

- **Result of the evaluation** could be either "satisfactory" or "need improvement"
- It is the responsibility of the ERN and HCP to issue an **improvement plan**



The **Board of Member States (BoMS)** receives information from the EC regarding the evaluation process and results. It issues the final decision on the continuity or termination of the ERNs and their members

Key tasks of the BoMS

Stage 4: Evaluation results 28 May 2023 – 04 Sep 2023


Purpose

Issue a report with the results of evaluation as well as comments and recommendations


Task

- Offer the ERN/HCP in question **one year** to implement the improvement plan annexed to the final report (“*not satisfactory*” only)
- Approve **any termination** of an ERN or loss of membership

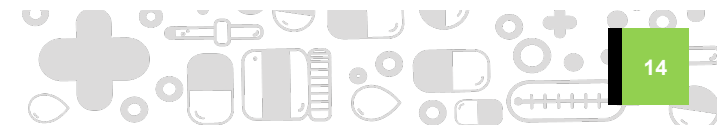

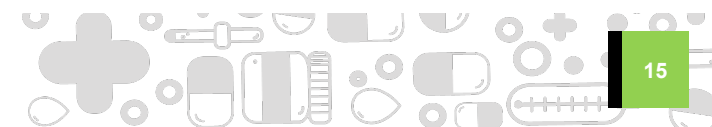


The evaluation of ERNs is based on verifying to which extent the ERNs and HCPs meet the **quality requirements** related to the achievement of the objectives for which they were constituted.

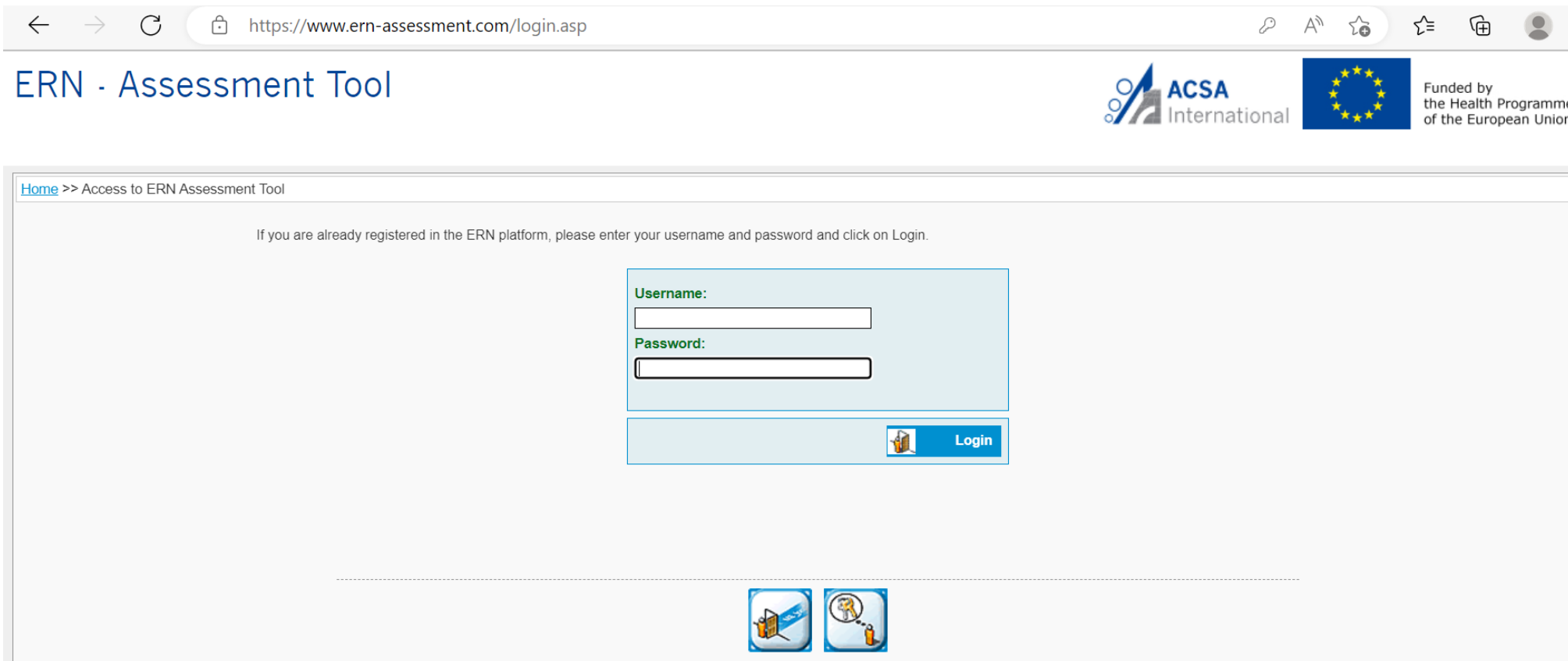


 **Core ME:** are considered essential to obtain a favorable evaluation.

Extended ME: refer to important areas in which ERNs or their Members should work on.

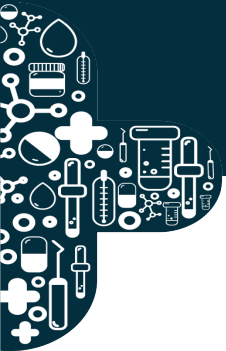


Each ERN/HCP should complete the self-evaluation through the online tool (OEIT) which can be accessed via the following URL: www.ern-assessment.com

■ Communication channels

Each ERN and HCP will be assigned an Evaluation Coordinator who will be the focal point during the whole evaluation process.

Communication channels

There are two main communication channels managed by qualified personnel and each has been set up for a specific purpose.

OEIT

Purpose:

Internal communications between applicant and IEB



Examples:

- How to interpretate quality requirements or other methodology clarifications
- Request of additional information or clarifications from the evaluators
- Set up dates for interviews and audits

- **27 Feb 2023 – 27 Mar 2023**
Perform online interviews [ERNs]
- **09 Mar 2023 – 18 May 2023**
Perform onsite audits [HCPs]

EVALUATION RESULTS

- Comments and amendments – **1,5 months draft report**
- Improvement plan (if needed) – **1,5 months draft report**
